Endowment Operating Protocols were revised at the 2023 Synod Assembly. Funds from The ECSW Endowment are used to maintain the property.

#### ▶ BUILDING SALE

The synod office building sale closes on December 15, 2023. Bishop Anne leads a service of leave-taking via Facebook live. Proceeds of the sale are housed with the ECSW Endowment fund.
